To stay away from the edges of the stage; 4. to always refer to qualified technicians for electrical and electronic components; 5. to do not place any material in the run-off area; 6. to do not enter the stage with sandals and/or open-toed shoes; 7. to do not stand under suspended loads or suspended elements, even on stage level, when moving; 8. to do not enter the stage unless permitted by their contact persons; 9. not to pass and/or stop in the stage construction and realization area where there is a danger of material falling from the top during the whole period of assembly and dismantling; to arrange with the technical manager the areas where you can operate;
- C. To always refer to the Coordinators and Managers of ME present on site;
- D. To exempt and relieve, with the signature of this, ME and/or its successors and/or collaborators from any and all civil and/or criminal liability arising from the participation of the child in the Festival, including for any accidents or injuries suffered and/or caused to himself and/or to third parties, including those resulting from the action of other participants, or any damage of any kind and type to persons and/or property suffered and/or caused to themselves and/or to third parties, committing ourselves not to take any judicial and/or extrajudicial action and in any case not to raise any exception with regard to the organisation of the Festival and with regard to ME and its successors and/or collaborators;
- E. To indemnify and hold harmless ME and/or its successors from any damage, prejudice, loss, cost, expense (including legal one) and sanction deriving from the violation by the minor of the behavioral rules provided herein and those of the Regulation published on the website of the Festival, that we declare to have seen and to know well, or resulting from his negligent conduct and/or malicious.

CONSENT TO THE PROCESSING OF PERSONAL DATA

Information pursuant to art. 13 of Law 21/12/2018 n. 171 and the GDPR – Regulation 2016/679, laying down provisions for the protection of persons and other subjects with regard to the processing of personal data, please note that the personal data provided will be processed in compliance with the aforementioned legislation.

- 1) **Data Controller and Data Processor:** The Data Controller of personal data of persons who, in various ways, will participate in the Festival "***Dreaming San Marino Song Contest***" 2026/2027 (henceforth Festival) is Media Evolution Srl (henceforth Media Evolution), in the person of the legal representative p.t., with registered office in Via III Settembre n. 99, Repubblica di San Marino, SM 47890, C.O.E. SM 29275 (Mail: info@dreamingsanmarinosongcontest.com). The Data Processor is Denny Montesi as legal representative of p.t. of Media Evolution Srl (Mail: info@dreamingsanmarinosongcontest.com).
- 2) **Purposes of processing:** Personal data will be processed for the purposes related to the Festival, as well as for all purposes of a promotional, advertising and/or commercial nature related to it.
- 3) **Legal basis of data processing:** The processing of personal data is based on consent pursuant to art. 5, par. 1, lett. a) of Law 171/2018, expressed by the interested party for the purposes indicated in point 2 above). The processing of personal data is necessary to fulfil a legal obligation to which the controller is subject for the purposes indicated in point 2 above.
- 4) **Source of personal data:** Personal data are collected directly from the data subject. The data are processed in compliance with the obligations of correctness, lawfulness and transparency imposed by the aforementioned legislation, protecting the privacy and rights of the data subject.
- 5) **Methods of processing and storage: The data** will be processed both in paper format, with computerized methods and, in any case, in order to ensure security and confidentiality in compliance with current legislation. The Data Controller undertakes to guard and control personal data by adopting the appropriate technical and organizational measures necessary to counter the risks of destruction or loss, unauthorised access or processing that is not permitted or not in accordance with the purposes for which they were collected. In compliance with the principles of lawfulness, purpose limitation and data minimization, the data of data subjects will be stored for the period of time necessary to achieve the purposes for which they are collected and processed.
- 6) **Scope of communication and dissemination:** The data collected may be communicated for the purposes mentioned above to third parties, subject to express explicit consent at the bottom of this information, except for communications necessary for the fulfilment of legal obligations.
- 7) **Transfer of personal data abroad:** The data will not be transferred either in Member States of the European Union, or in third countries not belonging to the European Union.
- 8) **Special categories of personal data:** Data that qualifies as "special categories of personal data" namely data that reveal racial or ethnic origin, data relating to the health or sexual life or sexual orientation of the person, political and trade union, religious, philosophical and other comparable beliefs, as well as data relating to criminal convictions and crimes will be processed exclusively with the consent of the data subject.
- 9) **Consent of minors:** Data relating to persons under the age of 16 may be processed only with the consent of the holder of parental responsibility, expressed in writing at the end of this information.
- 10) **Rights of the interested party:** At any time, the data subject may exercise, pursuant to art. from 15 to 22 of Law 171/2018, the right to: a) request confirmation of the existence personal data; b) access at any time to data concerning the data subject; c) obtain information on the purposes of the processing, the categories of personal data, the recipients or categories of recipients to whom the personal data have been or will be communicated and, where possible, the retention period; d) obtain rectification and deletion or the blocking of data; e) obtain restriction of processing; f) obtain the portability of the data, that is to say receive it from a controller, in a structured, commonly used and machine-readable format, and transmit it to another controller without hindrance; g) oppose the processing at any time for legitimate reasons; h) oppose an automated decision-making process concerning individuals, including profiling; i) request the controller to update, supplement or restrict the processing concerning his/her data; j) withdraw consent at any time without prejudice to the lawfulness of the processing based on the consent given before the withdrawal; l) lodge a complaint with a supervisory authority.
