

Information Notice on the Processing of Images and Personal Data for the Participation of Minors in Programmes and Journalistic Services of San Marino RTV

1. What is this document?

With this document, we inform you how and for what purposes we collect your personal image and your personal data in connection with your participation in television programmes and journalistic services produced and broadcast by San Marino RTV.

2. What are the legal references?

- Law no. 171 of 21 December 2018 of the Republic of San Marino.
- European Regulation 679/2016 (GDPR).
- Law no. 8 of 25 January 1991 as amended (Copyright Protection), in particular Articles 90–91–92.
- Italian Civil Code (Article 10).
- Italian Law no. 633 of 22 April 1941 as amended (Copyright Protection), in particular Articles 96 and 97.

3. Identity and contact details of the Data Controller

The Data Controller is San Marino RTV S.p.A. – Radiotelevisione della Repubblica di San Marino (hereinafter also “Controller” or “San Marino RTV”).

The Controller is located at Viale J.F. Kennedy no. 13, 47890 San Marino, Republic of San Marino, and can be contacted for further information regarding the processing at the following addresses: amministrazione@sanmarinortv.sm – +378 0549/882000.

4. Contact details of the Data Protection Officer

The Controller has appointed a Data Protection Officer, who may be contacted by e-mail at the following address: dpo@sanmarinortv.sm for any matter related to the processing of your personal data.

5. For what purposes do we collect your image and personal data?

San Marino RTV collects your image and personal data for informational and journalistic purposes within its programmes and journalistic services, the recordings of which may be published through San Marino RTV channels (television channel, website, social networks). Your identifying personal data are also collected to verify the proper expression of consent to the processing.

6. When may we process your image and personal data?

San Marino RTV may collect and process your image and personal data for informational and journalistic purposes **only on the basis of your explicit, informed and express consent**.

Providing your personal data is not compulsory, nor is it compulsory for your image to be collected and processed within San Marino RTV programmes and journalistic services. Refusal to provide consent does not allow San Marino RTV to use your image and personal data for the purposes described above.

7. How long do we retain your image and personal data?

Your images and personal data are retained for the period necessary to achieve the purposes of the processing indicated above.

The Controller ensures that processing is discontinued and that all processed data are fully deleted should you exercise your right to withdraw previously given consent or submit an objection, unless the Controller has a prevailing legitimate interest in their retention.

8. How is the processing carried out?

The use of your image and personal data is carried out in a manner that does not harm your honour, reputation or dignity.

The Controller processes your data using magnetic, electronic and telematic tools, ensuring security, confidentiality, accuracy, updating and relevance of the data with respect to the purposes indicated.

Your data will also be processed by internal and external subjects authorized by written acts providing proper instructions to ensure adequate data protection.

Your personal data are stored within the physical and electronic archives of the Controller within the territory of the Republic of San Marino.

Your image and personal data may be disseminated through San Marino RTV channels if you have consented to the processing.

9. What rights can you exercise?

The processing of your data is carried out in compliance with the principles of fairness, lawfulness, transparency, confidentiality and your recognized rights.

You may exercise the rights granted by Regulation (EU) 2016/679 and Law no. 171 of 21 December 2018, including the right to request access to your processed data, the right to data portability, the right to rectification or erasure, the right to restrict processing, as well as the right to lodge reports or complaints with the competent Supervisory Authority.

You are also entitled to object to the processing of your data.

Finally, you are entitled to withdraw your consent at any time without affecting processing previously carried out, by notifying the Controller via registered mail or e-mail at the address indicated above.

We sincerely thank you for your attention and cooperation and kindly invite you to provide your consent to the processing described as soon as possible.

DECLARE

to comply with and ensure compliance with the rules of good conduct and behaviour, including but not limited to:

1. not smoking or using open flames;
2. not accessing areas other than those assigned by the stage manager;
3. not approaching the edges of the stage;
4. referring exclusively to authorized technicians for electrical and electronic components;
5. not placing any materials in marked emergency exits;
6. not accessing the stage wearing sandals and/or open footwear;
7. not standing under suspended loads or elements, including at stage level, when they are being moved;
8. not accessing the stage except when instructed to do so by one's designated referents;
9. not passing through and/or standing in the construction area of the stage, where there is a risk of falling materials from above during assembly and disassembly;
10. coordinating with the technical director regarding the areas where activity is permitted;

to release and hold harmless, by signing this document, San Marino RTV and Media Evolution and/or their successors from any and all civil and/or criminal liability arising from participation in the Festival, including any accidents or injuries suffered and/or caused to oneself and/or to third parties, including those resulting from the actions of other participants, as well as any damage of any kind or nature to persons and/or property suffered and/or caused to oneself and/or to third parties, undertaking not to take any legal and/or extrajudicial action and in any case not to raise any objections regarding the organization of the Festival against San Marino RTV and Media Evolution and their collaborators;

to indemnify and hold harmless San Marino RTV and Media Evolution and/or their successors from any damage, loss, cost, expense (including legal fees) and sanction arising from violations committed by me and/or my collaborators of the rules set forth herein and those in the Festival Regulations published on the official website, which I declare I have read and fully understand, or arising from negligent and/or willful conduct;

to assign and transfer exclusively to San Marino RTV, represented by its legal representative pro tempore, with registered office in San Marino (RSM), Viale J. F. Kennedy 13:

- the right to film and/or photograph and/or record, including through authorized third parties,

by television, cinematographic, photographic and phonographic means, on film, tape or any other medium existing or to be invented in the future, the minor's image, voice, name and artistic performances render during the entire Festival, with full right for San Marino RTV to reproduce, disseminate, transmit, make available, duplicate, edit, combine, synchronize, print, publish and project the footage and/or photographs and/or recordings, whether in their entirety or in part, together with the Festival or separately, by any means currently known (by way of example and without limitation: terrestrial TV, satellite, cable, radio, web radio, web TV, social networks, internet, downloading, streaming, analogue and/or digital systems, DVB-T, DVB-H, DVB-X, online and offline, fixed and mobile telephony, UMTS, GPRS, HSDPA, etc.) or to be invented in the future, in any form and manner, without any time and/or territorial limitation, through websites, web radio, web TV, social networks, etc., including through total and/or partial assignment to third parties and for the entire duration of legal protection in all countries of the world;

- the right to associate the aforementioned footage and/or photographs and/or recordings with advertising and/or promotional messages related to the Festival and to carry out the broadest advertising exploitation thereof;
- the right to process the personal data I have provided to the Festival for purposes related to the conduct of the same, as well as for all promotional, advertising and/or commercial purposes connected thereto, expressly authorized through the signing of the Privacy Notice;
- the undersigned expressly authorizes San Marino RTV or its assignees to commercially exploit the performance concerned without any claim whatsoever in this regard, forever;

to have nothing to claim from San Marino RTV and/or its successors regarding the assignment and uses described above.

San Marino RTV and/or its successors shall therefore be the video-phonographic owner of the footage, photographs and recordings mentioned above, as well as of all said materials possibly produced.

I UNDERTAKE

to maintain confidentiality, until the official announcement has been made, regarding the Festival results, acknowledging that failure to comply with this obligation will result in disqualification from the Competition and a penalty of EUR 15,000;

to consent to having photographs taken alone and in groups with the other finalists and to giving television interviews to be used during the semi-finals and the eventual Final of the San Marino Song Contest 2027;

in the event of winning the Competition, to register on behalf of the Republic of San Marino for the Eurovision Song Contest 2027, signing all necessary documentation for this purpose and complying with all obligations, requirements, formalities and deadlines for registration, doing all that is necessary for registration and participation in the Eurovision Song Contest 2027;

in the event of advancing in the Dreaming San Marino Song Contest 2027, to participate as a contestant in the semi-finals of the San Marino Song Contest 2027 and in the eventual final of the event.
