Information notice on the processing of images and personal data for the participation of adults in journalistic programmes and services of San Marino RTV

1. What is this document?

With this document, we inform you how and for what purposes we collect your personal image and your personal data in relation to your participation in television programme and/or journalistic services produced and broadcast by San Marino RTV.

2. What are the legal references?

- Law of 21 December 2018 no. 171 of the Republic of San Marino
- European Regulation 679/2016 (GDPR)
- Law of 25 January 1991 no. 8 and subsequent amendments (Copyright Protection), in particular Articles 90–91–92
- Italian Civil Code, Article 10
- Italian Law of 22 April 1941 no. 633 and subsequent amendments (Copyright Protection), in particular Articles 96 and 97

3. Identity and contact details of the Data Controller

The Data Controller is San Marino RTV S.p.A. – Radiotelevisione della Repubblica di San Marino (hereinafter also “Data Controller” or “San Marino RTV”).

4. Data Protection Officer (DPO) contact details

for any matter regarding the processing of your personal data.

5. For what purposes do we collect your image and personal data?

San Marino RTV collects your image and personal data for informative and journalistic purposes within the programme and journalistic services produced and published on San Marino RTV channels (television channel, website, social networks).

Your identifying data are also collected in order to verify the valid expression of consent to such processing.

6. When may we process your image and personal data?

San Marino RTV may collect and process your image and personal data for informative and journalistic purposes only on the basis of your explicit, informed and unambiguous consent. Providing your personal data and authorizing the collection of your image is not mandatory; however, refusal to provide consent prevents San Marino RTV from using your image and data for the purposes described above.

7. How long do we retain your image and personal data?

Your images and personal data are kept for the time necessary to achieve the purposes described above.

The Controller guarantees the interruption of processing and the complete deletion of the data upon your withdrawal of consent or exercise of your right to object, unless the Controller has a prevailing legitimate interest in their retention.

8. How is the processing carried out?

Your image and personal data are used in a manner that does not harm your honour, reputation or dignity.

The Controller processes your data using magnetic, electronic and telematic tools, ensuring security, confidentiality, accuracy, updating and relevance of the data with respect to the stated purposes. Your data may also be processed by internal and external personnel authorized in writing, and instructed to ensure adequate data protection.

Your personal data are stored in physical and electronic archives located within the Republic of San Marino.

Your image and personal data may be disseminated through San Marino RTV channels if you have consented to such processing.

9. What rights may you exercise?

Your data are processed in accordance with the principles of fairness, lawfulness, transparency and protection of confidentiality and rights.

You may exercise the rights provided under Regulation (EU) 2016/679 and Law no. 171/2018, including the right of access, rectification, erasure, restriction of processing, portability of data, and the right to lodge a complaint with the competent Supervisory Authority.

You also have the right to object to the processing of your data.

Finally, you may withdraw consent at any time—without affecting the lawfulness of processing performed before withdrawal—by sending written notice via registered mail or e-mail to the Controller at the addresses indicated above.

RELEASE AND WAIVER OF LIABILITY

I, the undersigned _____,

DECLARE

to respect and ensure respect for rules of good conduct and behaviours, including but not limited to:

1. not smoking or using open flames;
2. not accessing areas other than those assigned by the stage manager;
3. not approaching the edges of the stage;
4. referring exclusively to qualified technicians for electrical and electronic components;
5. not placing any materials in designated emergency exits;
6. not entering the stage wearing sandals or open footwear;
7. not standing under suspended loads or hanging elements, including at stage level, during movement;
8. not accessing the stage except when instructed by authorized personnel;
9. not crossing or remaining in the construction and assembly/disassembly area of the stage,

where there is a risk of falling materials;

10. coordinating with the technical site manager regarding permissible operating areas;

to release and hold harmless San Marino RTV and Media Evolution, and/or their successors, from any civil and/or criminal liability arising from participation in the Festival, including any accidents or injuries suffered or caused to myself or third parties, including those resulting from the actions of other participants, as well as any damage of any kind to persons and/or property suffered or caused to myself or others. I undertake not to bring any legal or extrajudicial action and not to raise any objection concerning the organization of the Festival against San Marino RTV, Media Evolution or their collaborators;

to indemnify and hold harmless San Marino RTV and Media Evolution, and/or their successors, from any damage, loss, cost, expense (including legal fees) or sanction resulting from any breach by myself and/or my collaborators of the rules set out herein or in the Festival Regulations published on the website, which I declare to have read and understood, or resulting from negligent or willful conduct;

to assign and transfer to San Marino RTV, in the person of its legal representative, with a registered office in San Marino (RSM), Viale J. F. Kennedy 13:

- the right to film and/or photograph and/or record—with the use of television, cinematic, photographic or audio equipment, or any present or future technology—my image, voice, name and artistic performances during the Festival, with full right for San Marino RTV to reproduce, disseminate, transmit, make available, duplicate, edit, synchronize, print, publish or screen the footage and/or photographs and/or recordings, in whole or in part, together with the Festival or separately, using any means currently known (including terrestrial TV, satellite, cable, radio, web radio, web TV, social networks, internet, downloading, streaming, analogue and digital systems, DVB-T, DVB-H, DVB-X, online/offline systems, fixed and mobile telephony, UMTS, GPRS, HSDPA etc.) or that may be invented in the future, without time or territorial limitations, and also through total or partial transfer to third parties, for the entire duration of legal protection and in all countries of the world;
- the right to associate such recordings, footage or photographs with advertising and/or promotional messages relating to the Festival and to exploit them for advertising purposes;
- the right to process the personal data I provide for the Festival for purposes relating to its organization, as well as promotional, advertising and/or commercial purposes connected to it, expressly authorized by signing the Privacy Notice;
- I expressly authorize San Marino RTV, or its assignees, to commercially exploit the

above-mentioned performance without any claim from me, indefinitely;

to have no claim whatsoever against San Marino RTV and/or its successors regarding the assignment and uses described above. San Marino RTV, and/or its successors, shall therefore be the exclusive owner of the video, photographic and audio recordings and any related materials produced.

I UNDERTAKE

to maintain confidentiality, until the official announcement, regarding the Festival results, acknowledging that violation of this obligation will result in disqualification and a contractual penalty of €15,000;

to consent to individual and group photographs with the other finalists and to give television interviews to be used during the semi-finals and the eventual Final of the **San Marino Song Contest 2027**;

in the event of winning the Contest, to register on behalf of the Republic of San Marino for the Eurovision Song Contest 2027, signing all necessary documentation and complying with all obligations, formalities and deadlines required for registration and participation;

in the event of advancing in the **Dreaming San Marino Song Contest 2027**, to participate as a contestant in the semi-finals and the eventual final of the **San Marino Song Contest 2027**.
